As of June 30 2022 we had 133 members and 90% renewed

Average events rating of 9.2, better than last year

5 new forums launched

Members were placed within 37 days on average

As of June 30 2022 we had 22 Accelerators and 100% renewed

4 Accelerators graduated into EO

Other initiatives:

Name changed to EO Queensland and was received well by the members

Started 1 on 1 meetings

Supported Intentional Women's Day and Women of EO Retreat

Set up the president's council meeting cadence

Three-year plan on a page, continues to move forward in a structured way

## 21/22 FINANCE REPORT (MATTHEW BELLGROVE)

Challenging environment coming into last year as we cut membership dues in half the year prior

Simple approach, growth of new members and retention

Additional expense in marketing to support new member growth

Events and travel was much higher than previous year coming out of Covid

A lot of work has been put into Xero, reporting is now consistent under board roles and area of chapter so we can understand where we are investing member's money

Income is up 29% from previous year



KEP income was less as second year is discounted

\$65,000 in government was received in prior year and not this year

Operating expenses went up because we added additional staff to support growth

Training and program expenses increased

Net result was \$26,000 in operating profit which is net \$11,000 over two years which is a good outcome considering COVID

We established three separate accounts, reserves account (6 months of operating expenses) and two to separate current and following year membership income and expenses

Under Jason's tenure, there will continue to be better financial visibility in Xero, improved budgeting which will ultimately assist incoming board roles to better prepare themselves
