SPECIAL BUSINESS

Proposed Special Resolution – To change the name of the association from "Entrepreneurs' Organization Brisbane Inc" to "Entrepreneurs' Organization Queensland Inc"

- 41% members reside outside of Brisbane Core Metro Area
- The change of name will make the membership feel more inclusive and make it more appealing to those who live outside of Brisbane
- Not changing it may miss opportunities Shannon Semenikow referenced EO New Zealand
- Name change will not impact fees



Questions:

- Linus Chang requested clarification of 'long commute' this was met with an explanation of members outside Brisbane area such as Gold Coast & Sunshine Coast travelling to Brisbane for events and forum meetings
- Olivia Morland raised question of cost to change the collateral for the name change this was met with an explanation that besides a nominal administration fee, the exact costs were unknown
- There was general conversation around being inclusive of potential members
- The name change is about catching up with the current regional activity
- Alan Kepper suggested buying domain names such as EO North Qld, EO Toowoomba etc
- Nick Bloor commented that it is "progressive change" he suggested seeking member consultation as to how to the Chapter grows regionally
- Christine Green suggested that it ties in well with the 3-year plan
- Jason Lawrence clarified that the name change needs to be voted on at the AGM but all the changes are not happening right away
- Linus Chang shares that once a chapter gets over 170-200 members there can be internal tension to start new chapters.

Gerard calls for two scrutineers to count the votes.

Adam Thompson & Shannon Semenikow volunteer

75% of members (24) need to vote in favour of the special resolution to pass

30 members vote in favour of the name change and 2 Members against.
